2. Last date of sale of tenders is **26-09-2017** at 03.00 p.m.
3. Last date of submission of tenders will be **27-09-2017** at 02:00 p.m.
4. The technical proposals will be opened on the same day at 02:30 p.m. in the presence of bidders / representatives of the bidders.
5. Tender must be sealed / complete in all respects and should reach in the office of the Secretary, BISE, Faisalabad before the closing date and time.
6. The purchase will be made under PPRA Rules (single stage two envelopes).
7. Bid security @ 5% of estimated price i.e. Rs. 19600000/- , Rs. 12350000/- ,Rs. 5250000/-, Rs.3900000/- of items at serial no.1,2,3,4. respectively in the shape of CDR must be attached. Tender shall not be accepted without CDR.
8. Incomplete and late bid will neither be accepted nor entertained.
9. The department reserves the rights to accept or reject all tenders in accordance with PPRA rules 35.
10. In case of any dispute the decision of the Chairman will be final and will be accepted for both parties.
