2. Last date of submission of tender will be **22-02-2018** at **01:00 p.m.** in the office of Secretary, BISE, Faisalabad.
3. The last date of opening the tender i.e. **22-02-2018** at **1:30 p.m.** in the presence of bidders/representative of the bidders.
4. The bidding documents will be issued to the contractor after date of publication as per PPRA Rule 25(1).
5. The tender documents can be obtained immediately after the publication of date of tender from Estate Branch on the payment of **Rs.10,000/-** in the shape of draft / pay order /Challan form in the favor of Secretary BISE, Faisalabad.
6. Tender must be sealed/completed in all respects and should reach in the office of the Secretary BISE, Faisalabad before the closing date and time. The tender documents obtained from BISE on payment will only be accepted.
7. Incomplete and late tenders will neither be accepted nor entertained.
8. The tender rates & amount should be filled in figure as well as in words.
9. The rates will be evaluated/compared item wise.
10. Bid security @ 2% of estimated price must be attached with bid in favor of Secretary BISE, Faisalabad. Tender shall not be accepted without CDR.
11. The successful bidder will deposit 10 % amount of the contract as Performance Guarantee.
12. The procuring agency have right to reject all bids or proposals at any time prior to the acceptance of a bid or proposal.

The lowest bidder, whose bid will be less than 5% of the estimated cost of the work, will have to deposit additional performance security in shape of CDR or Bank guaranty from schedule Bank the difference which will be returned on successful completion of the contract, as per standing instruction of Govt. of Punjab Failure to deposit the different within seven days of the notice, the deposited earnest money will be forfeited without further notice.
